# 1. Purpose

The purpose of this procedure is to facilitate information to Trakhees clients regarding the control the process of issuing and renewal of environmental permit/ no objection letter.

# 2. Scope

All projects with significant environmental impacts within the Trakhees jurisdiction areas. See table below for applicability of each type of Environmental Permit or NOC.


# 4. Procedure

### 4.1 Issue a New Environmental Permit/ NOC:

- 4.1.1 Client should submit the application form as below with other required documents mentioned in each application to Inspection department in Jebel Ali or through mail to (Milagros.lligan@trk.pcfc.ae)
  - 4.1.1.1 Environmental Permit (Harbor / Open Sea Discharge, Irrigation and Air Emission) Application Form (CEN-F02a)
  - 4.1.1.2 Groundwater Discharge Permit Application Form (CEN-F02b)
  - 4.1.1.3.Permit to Cut and/or Relocate Trees Application Form (CEN-F02c)
  - 4.1.1.4 Permit to Operate Captive Marine Mammal and/or Public Aquarium Facility Application Form (CEN-F02d)
  - 4.1.1.5 Permit to Transport Marine Mammal and/or Aquatic Animal Application Form (CEN-F02e)
  - 4.1.1.6 Permit to Conduct Scientific Research Marine Mammal and/or Aquatic Animal Application Form (CEN-F02f)
  - 4.1.1.7 Permit to Export / Import Marine Mammal and/or Aquatic Animal Application Form (CEN-F02g)
  - 4.1.1.8 No Objection Certificate (NOC) Conditional Environmental Activity Application Form (CEN-F02k)
  - 4.1.1.9 Permit to Transport Sand Application Form (CEN-F02cl)
- 4.2 Inspection Department will review the submitted documents and will send copy of payment advice to clients with the status of the submission as below:
  - 4.2.1 Approved: once all required documents are available and information complying the requirements of Trakhees. Client should settle the payment and notify the inspection department.
  - 4.2.2 More Details: in case of missing of any of submission requirements or more details need to be given by the client. Client should update the required information and settle the payment and send to inspection department.
  - 4.2.3 Reject: in case the applied company does not comply with the Trakhees regulation, environment officer should state clearly in the mail the reason for rejecting the application.
- 4.3 Client should settle the payment and inform Inspection department.
- 4.4 Site might be inspected by the inspection department as needed.
- 4.5 Upon submission approval client will receive Vehicle Pass on his/her mail.

# 4.2 Renew an Environmental Permit/ NOC (Applicable only for Air Emission, Irrigation and for Harbour Discharge)

- 4.2.1 Inspection department will initiate the renewal process, inspection by environment department and laboratory shall be conducted without prior notice to the client.
- 4.2.2 Once the inspection is done, client will receive payment advice through the client email with any findings raised within the inspection. As soon as the corresponding analysis report/s has been released the same will be sent to client.
- 4.2.3 Client should settle the payment and the client should act for compliance with the applicable standards and to inform the inspection department with the findings closure and payment settlements.
- 4.2.4 Re- inspection and/or re-testing of the site might be needed, in case re-testing is required, payment advice will be issued and sent to client for settlement.



4.2.6 In case the client failed to respond to the inspection/ testing findings, client might be subjected to financial penalty which must be settled prior to permit renewal.
