1. PURPOSE:

The Import, export, use, storage and monitoring of radioactive sources are broadly governed at state level by Federal Authority for Nuclear Regulation (FANR).

Accordingly, Radiography Permits are required to be obtained for entry of Radioactive sources and carrying out Radiography in Trakhees' jurisdictional areas.

2. SCOPE:

This permit is applicable for all radiography activities within Trakhees' jurisdiction.

3. DEFINITIONS:

ID – Inspection Department of Trakhees

JAFZA – Jebel Ali Free Zone Authority

NOC – No Objection Certificate

FANR – Federal Authority for Nuclear Regulation

4. PROCEDURE

4.1 **Initial Approval:** The client shall obtain necessary License/ Approval/ Permission from the Federal Authority for Nuclear Regulations (FANR):

4.2 **Review:** After obtaining Approval/ License from the FANR, the client or Contractor shall submit the request through Online System along with relevant documents 2 days in advance for bringing in radioactive source and/or for carrying out radiography works in PCFC – Trakhees' jurisdictional areas.

TRAKHEES shall check all of below documents:

- a. DED Trade License
- b. FANR License



- c. FANR Approvals/Import
- d. Vehicle approval
- e. Source Certificate
- f. Classified Person Certificate
- g. Radiation Protection Officer Certificate
- h. Risk Assessment
- i. Method Statement
- j. Emergency Response Plan

4.3 Inspection/Approval: Trakhees (on a case-to-case basis) may inspect and check the packaging container/box, transporting vehicle, radiation emission level from the source and site of works. Upon satisfactory compliance of all requirements and where documents are in order, Trakhees shall issue a "Radiography Permit" for bringing the radioactive source and carrying out the radiography in the Trakhees jurisdiction not later than 2 days from the date of submission.

4.4 Notes:

- a. Radiography Permit is issued for clients having proper Radiography Bunker and Facility for carrying out Radiography in safe manner.
- b. The Radiography Company shall transport the Radiography source from their facility to their client site in a proper approved Vehicle while displaying Radiation Sign Boards, fitted with Beacon Light and Lead Shield Box.
- c. Radiography Permit issued by Inspection Department (formerly known as EHS) shall be always available with the classified person carrying out Radiography and must be shown on request of the Authority.
- d. All clients carrying out Radiography shall develop their own appropriate Radiographic Emergency Response plan.

Fee for review shall be paid prior to the submission of application, clients is required to top-up their pre-paid account to enable submission to proceed in Online System

* All applications are required to pay the Knowledge Dirham and Innovation fees at a total amount of AED 20/- for each Radiography Permit, which is issued for a month.
